THE ACTUAL FEE PAYABLE WILL BE CALCULATED BY MEASURING THE FOOTPRINT AREA OCCUPIED BY THE VESSEL AND TRAILER WHEN ASHORE AND ANY EXCESS OR REBATE DUE WILL BE NOTIFIED AT THE NEXT ANNUAL INVOICE. FOR CRUISERS BOTH A MOORING AND POUND SPACE ARE CHARGABLE AND CANNOT BE SEPERATED EVEN IF NOT LAUNCHED. LARGE VESSELS OCCUPYING ROWS X OR Y WHICH CANNOT BE HAULED OUT AT THE CLUB WILL BE CHARGED AN ANNUAL MOORING FEE.

The creek area is generally reserved for owners with cruisers too large to have a pound space ashore or where owners have disabilities. Please apply directly to the Pound Master for a space by the creek.
